I. Call to Order - Kirk Stephens called the meeting to order at 3:00 PM.

A. Kirk welcomed the new committee members and held roundtable introductions

Approval of Minutes – The minutes from 3-5-15 and 5-5-15 meetings were sent to the committee prior to meeting. Kirk asked if there were any comments or corrections. No corrections were made.

William Brothers motioned to accept the minutes as written. Melody Lawrence seconded the motion. The motion passed.

II. Open Issues

A. Arts & Sciences, Barbara Putman

- 1. Associate in Science Spring 2016.
 - a) Add BIO 168, BIO 169 and BIO 175 as additional elective options for students who plan to major in Biology, Nursing or pre-medical fields. These courses are already in the AS degree.

Mitch Fischer motioned to accept the proposed courses. Diane Page seconded. The motion passed.

B. Career Technologies, William Brothers

- 1. Accounting Diploma, Spring 2016
 - a) Add a diploma option to the credential offering for Accounting. This will not be financial aid eligible.
 - b) The diploma will include 42 SHC (see attachment for course listing)

- e) Delete: MED 120 (replace with MED 121 and 122), HSC 120

- c) Delete: MED 120, BIO 110, HSC 120, and HEA 110

Cheryl Contino Conner motioned to accept the proposed changes with the exception for Mitch to reconfigure Nurse Aide CHM situation. Diane Page seconded. The motion passed.

III. Other Business

A. Voting/Non-Voting Members – Thom Brooks

Thom explained the rationale behind having voting and non-voting members of the C&I Committee. The focus of the committee is for the will of faculty to have control of curriculum through vote. Instead of making a larger committee, we will give only the faculty the right to vote. Any member can make a motion but cannot vote. Kirk also clarified that the ex-officio has the right to vote as well.

B. Program Terminations - Thom Brooks, effective immediately

Thom brought a list of programs which have had no enrollment in two or more years to the table for official termination with the System Office. One program, Basic Law Enforcement Training (C55120) we will keep because there is hope to get enrollment in this one soon. Terminations are as follows:
