A. Arts and Sciences – Barb Putman

- 1. Associate in Arts AA, Fall 2017
 - a) Add: AST 111, AST 111A, CHM 130, CHM 130A, CSC 151, CTS 115 to elective options
 - b) Add: AST 111 and AST 111A to Natural Science option
- 2. Associate in Science AS, Fall 2017
 - a) Add: AST 111, AST 111A, CSC 151, CTS 115, HEA 110 to elective options
 - b) Add: AST 111 and AST 111A to Natural Science option
- 3. **Informational Item:** Associate in Fine Arts has been revised with a new curriculum code and will bring to the next C & I meeting once the program courses have been finalized. Associate in Engineering was approved by the SCC Board of Trustees but the AS division will continue to study the program for implementation. Possibly bring to the next meeting for approval.

1. Respiratory Therapy – AAS, Fall 2017

2. Phlebotomy - Certificate, Fall 2017

a) Reactivate the Phlebotomy certificate in the fall, exactly the way it was offered in the 2015-2016 catalog. (PBT 100, PBT 101 & PSY 150). The certificate is not available for financial aid. Phlebotomy will still continue to run in Workforce Innovations during the spring semesters.

Barb Putman motioned to accept the activation of Phlebotomy. William Brothers seconded. The motion passed unanimously.
