I. Call to Order – Kirk Stephens called the meeting to order at 9:00 AM.

A. Approval of Minutes

After Kirk called the meeting to order and welcomed the new committee members, he briefly stated the committee is driven by catalog deadlines and the function of the committee affects college operations. Then he asked for discussion on the following minutes:

1. October 12, 2016 meeting

There was no discussion. William Brothers motioned to accept the minutes. Diane Page seconded the motion. The motion passed unanimously.

II. Open Issues

A. Arts and Sciences – Barb Putman

1. Associate in Arts – AA, Fall 2017

- a) Add: GER 111 and GER 112 as humanities/fine arts as well as to the electives with the accompanying labs GER 181 and GER 182
- b) Add: EGR 150 to electives
- c) Delete: CHI 111, CHI 112, CHI 181, CHI 182 from the program

2. Associate in Science – AS, Fall 2017

- a) Add: GER 111, GER 112, GER 181 and GER 182 to electives
- b) Add: EGR 150 to electives
- 3. **Informational Item:** Still working on Associate in Fine Arts revisions. It is the decision of AS faculty and administration to postpone Associate in Engineering until further information can be gathered.

Hilary Seagle motioned to accept the proposed changes. William Brothers seconded. The motion passed unanimously.

B. Career Technologies – William Brothers

- 1. Early Childhood Education AAS, Fall 2017
 - a) Add: ART 111 and PHI 240 to humanities
 - b) Delete: HUM 122 and HUM 160 from humanities

2. Early Childhood Administration – certificate, Fall 2017

- a) Add this new 16 credit hour certificate to program offerings. The college will need to seek Board of Trustee approval, gather Impact Assessment information and notify SACSCOC. The program can be offered online and will include the following courses that we currently offer:

- g) Move: COM 140 to Spring 2 (after discussion)
- h) Move: ENG 114 to Fall 2
- i) Move RCP 132 to Fall 1

- k) Delete: RCP 144 RCP 156, RCP 214, RCP 238, RCP 212
- I) There was much discussion about the original proposal to move MAT to the last semester of the program. The committee looked into a way to move it up. It was determined to move it to Fall 2 and leave COM 140 in its original sequence of Spring 2. These changes will bring increased lab time and slightly decrease the clinical hours. The program decreased by one credit hour.
- 2. Medical Laboratory Technology AAS, Fall 2017
 - a) Move: MLT 253 to Spring 2 and MLT 116 to Fall 1
 - b) Add: CHM 130, CHM 130A, MAT 143, MLT 251, MLT 261 and MLT 276
 - c) Delete: BIO 111, MLT 118, MLT 271, MLT 272, MLT 274
- 3. Phlebotomy Therapeutic & Diagnostic Services Diploma, Fall 2017
 - d) Move PBT 101 to Fall 1 and HSC 120 to Spring 1
 - e) Add: CHM 130, CHM 130A
 - f) Delete: BIO 111

Cheryl Davids motioned to accept the proposed changes from Health Sciences with the revision of MAT and COM in Respiratory. Hilary Seagle seconded. The motion passed unanimously.

III. Other Business

A. Information Item – Kirk Stephens & Committee

The language of the Administrative Withdrawal Policy could make the faculty feel like the "bad guy." Student Services provided information that the language has improved (no change to the policy itself, just the language of the communication to student). An idea was thrown around to possibly change the WF (withdrawn by faculty) to AW (Administrative withdrawal) so that students do not think they have received an F. More discussion to come. Kirk will also discuss additional self-withdrawal with Thom.
