II. Open Issues

A. Arts and Sciences – Barb Putman

1. Associate in Fine Arts in Visual Arts – AFA, Fall 2018

- a) Add: ART 240 and ART 241 (Painting I and II)
- b) Delete: ART 231 and ART 231 (Printmaking I and II)
- c) Add a local certificate: Art Foundation Core which consists of ART 114, ART 115, ART 121, ART 122, ART 131

2. Associate in Arts – AA, Fall 2018

d) Dr. Putman realized that the addition of ART 240/241 and deletion of ART 231/232 would also need to go in the AA program but did not have a form.

Cheryl Contino Conner motioned to accept the proposed changes. Hilary Seagle seconded. The motion passed unanimously.

B. Career Technologies – Danell Moses

- c) TDS should be in teach out status from here on. The college will give students a year to finish out any diploma they are currently in (by end of Summer 2019) Starting in Fall 2018, students will be placed in AGE programs (according to their program). There also needs to be a procedure created for this.

Kirk Stephens motioned to accept the proposed addition of AGE Nursing and teach out of the TDS diplomas. Hilary Seagle seconded. The motion passed unanimously.
