1. **COMPLETE** the HOAE Registration Card.
2. **SIGNATURES REQUIRED:** Your signature and the signature of your advisor.
3. **FEE PAYMENT:**
 - a. **\$15.00 fee** must be paid by the deadline at the SCC Cashier's Office, 1st floor of Balsam.
 - b. Fee is valid for test dates during the **2008-09 Academic Year** and MUST be PAID by the deadline for the Test Date selected.
 - c. Fee is **nonrefundable** but may be applied to another test given during 2007-08 with valid documentation.
 - d. If you do NOT show for the test, you must reschedule for another test date during the 2008-09 year.
4. **TEST LOCATION:**
 - a. The test is given on the test date and in the location indicated.
 - b. Plan to arrive 15 minutes prior to test time.
5. **VALID CURRENT PHOTO ID REQUIRED:**
 - a. No admission to the test location is permitted without a valid current photo ID.
