A. Approval of Minutes

II.Open Issues

A. Health Sciences – Thom Brooks standing in for Melissa Hyatt

- 1. Emergency Medical Science Certificate, Spring 2023
 - a) ADD new Advanced EMT Certificate consisting of EMS 110, EMS 120 and EMS 121
 - b) Remove local corequisite of ACA 111 or ACA 122 on EMS 110

Cheryl Davids motioned to accept the EMS proposal. Meg Petty seconded. There was no opposition.

2. Dental Assisting - Diploma, Fall 2023

- a) ADD new Diploma to program offerings
 - The program is designed straight from the Curriculum Standard consisting of all DEN courses. It also includes required general education hours with ENG 111 and BIO 163. BIO 163 is a prerequisite to enter program.

Barbara Putman motioned to accept the proposed diploma. Danell Moses seconded. There was no opposition.

3. Human Services Technology – AAS, Spring 2023

- a) ADD the following:

5. Human Services Technology - Addiction & Recovery Studies - Diploma, Spring 2023

- c) Remove the AAS and LCAS Certificate. Add a Diploma to streamline courses between Human Services Technology & Addiction & Recovery. By adding a couple SAB courses to HSE, students will only need to take two additional SAB courses to complete the diploma.
