

UNIFORM TRAINING ATTIRE

Law Enforcement Training Academies at the Southwestern Community College – Public Safety Training Center (SCC-PSTC) are paramilitary in nature, commensurate with the tradition of the law enforcement profession. Uniform shirts and trousers are required for all classroom lectures, laboratories (LABs) and practical exercises (PEs). Recruits will maintain a neat, clean and professional appearance at all times. Recruits who attend SLET sessions without the appropriate uniform attire may be dismissed from the training session.

Prior to the delivery of a NPS-SLET Training Session, the Office of Law Enforcement Coordinator will publish & distribute a *Recruit Response Sheet* to assigned Recruits. The *Recruit Response Sheet* includes uniform procurement options and current pricing for available sizes.

NOTE: Applicants enrolled/assigned to a NPS-SLET training session after 01 March 2012, will be responsible for purchasing ALL required uniform items. In order to maintain our current, affordable course cost, SCC-PSTC will NO longer furnish uniform items from the Applicant's Supply & Material Fee (Deposit).

**PROVIDED FOR REFERENCE PURPOSES ONLY – prices are subject to change. For sizes larger than S – XL (i.e., XXL, XXXL, etc.), there is currently an additional \$2 charge for each X size increase. OSFA = "One Size Fits All." Tru-Spec 24/7 Series Trousers are available in EVEN sizes only (Waist x Inseam). When completing the Recruit Response Sheet, prior to the commencement of the assigned Training Session, it is the responsibility of the Recruit to round up, or round down, to the nearest EVEN size for both waist (W) and inseam (I). "Irregular" (defined by the manufacturer as "uncommon") sizes and inseams equal to, or greater than, 36" are shipped from the manufacturer as "un-hemmed." It is the responsibility of the Recruit to hem the trouser inseam length if received "un-hemmed" from the manufacturer.*

Uniform footwear, consisting of rubber-soled, black boots (at minimum, an ankle height military or law enforcement "tactical" style boot), capable of exhibiting military polish/shine, is required while wearing the Training Session uniform. Additionally, the Recruit will possess appropriate footwear for physical training (PT), consisting of traditional-styled running shoes and/or cross-training athletic footwear (i.e., footwear identified as "barefoot," or "minimalist," running shoes are prohibited during SCC-PSTC physical training sessions).

NPS-SLET Recruits will be attending training five (5) days a week, at minimum, and physical training (PT) will be conducted two (2) days a week, at minimum, during the duration of the

training session. Recruits should take this schedule into consideration when submitting uniform orders for their assigned training session.

Recruits assigned to a SCC-PSTC NPS-SLET Training Session will need to provide their own flashlight, over-the-ear style hearing protection and ballistic eye protection for use during *Firearms* training. Sub-freezing ambient temperatures are likely during the Fall Training Sessions, with specific training conducted outdoors. Recruits should bring sufficient apparel for these anticipated weather conditions, inclusive of personal rain gear. Appropriate attire for the *112: Courtroom TestimonyLAB* consists of professional business attire, inclusive of footwear. Camouflage clothing (either civilian manufactured or military specification) is required for the *805: Woodland Operations – Land Navigation/Tracking* training evolutions. At minimum, woodland pattern or olive drab (OD) battle dress uniform (BDU) shirt & trousers should be obtained for this training.
