PROGRAM OVERVIEW

The Human Services Technology Substance Abuse concentration prepares students to assist in drug and alcohol counseling, prevention-oriented educational activities, rehabilitation with recovering clients, managing community-based programs, counseling in residential facilities, and pursuit of four-year degrees.

Course work includes classroom and experiential activities oriented toward an overview of chemical dependency, psychological/sociological process, the twelve Core Functions, intervention techniques with individuals in groups, and follow-up activities with recovering clients.

Graduates should qualify for positions as substance abuse counselors, DUI counselors, halfway house workers, residential facility employees, and substance education specialists. With educational and clinical experiences, graduates can obtain certification by the North Carolina Substance Abuse Board.

PROGRAM HIGHLIGHTS

The Substance Abuse program offers step-by-step training of best practices by qualified North Carolina State Licensed Clinical Addiction Specialist instructors. Students learn specific knowledge of problem solving skills and critical thinking that translate directly to job readiness. Additionally, a large variety of professional and educational resources are available to all students within the program.

WHY SOUTHWESTERN

- The Substance Abuse Treatment certificate is designed to appeal to currently employed human services professionals who have an associate's, bachelor's or master's degree in related human services fields and are interested in gaining specialized training in the substance abuse field in counseling.
- The Human Services Technology and Substance Abuse curriculum encourages fellowship between human services students, offers opportunities for additional learning and networking, and promotes leadership.
- The Substance Abuse program is an approved provider for the North Carolina Substance Abuse Professional Certification Board.
- The program offers direct hands on co-op experiences at treatment agencies by Certified Clinical Supervisors.
- The Human Services Technology Department tracks available job openings in the region for its students and prepares them for entry into the job market.

AFTER GRADUATION

Upon successful completion of this program, graduates will be able to help people who have problems with alcohol, drugs, gambling and eating disorders. They will be able to counsel individuals who are addicted to drugs and identify behaviors and problems related to their addiction.

Upon graduation students are eligible to take the written examination from the North Carolina Substance Abuse Professional Certification Board. Upon passing, the graduate will then become a Substance Abuse Counselor Intern. The graduate may then function as a counselor under the supervision of a Board approved supervisor at a ratio of 1 hour of supervision for every 40 hours of practice. Graduates will be able to practice as a certified substance abuse counselor, and will be able to counsel individuals, groups and develop treatment plans.
