
UNCG is pleased to continue accepting students into the 2Plus program. The 2Plus program is for community college students who hold a specific Associate of Applied Science (AAS) degree or Associate Degree in Nursing (ADN) to pursue a specific UNCG major. Once admitted, 2Plus students pursue the same bachelor's degree as other members of their major field of study. I am enclosing an updated articulation notice, which details the community college AAS degrees that UNCG will accept for transfer into the 2Plus program and which majors students may choose.

Effective immediately, articulation notices have been added for two additional majors: Biology and Hospitality and Tourism Management. Student with AAS degrees in Biotechnology may major in Biology with any concentration. To enroll in the Hospitality and Tourism Management major, students must have earned an AAS degree in Hotel and Restaurant Management, Culinary Technology, Travel and Tourism Management, or Baking and Pasty Arts.

Also enclosed are the "2Plus Guidelines for North Carolina Community Colleges" and the "Individual School/Department Admission Requirements." The first sheet lists general guidelines of the 2Plus program. The second sheet lists individual department or school admission requirements, as acceptance to the 2Plus program does not constitute admission to any major.

Effective Spring 2005 this Articulation Notice replaces all previous Articulation Agreements or Notices for students seeking enrollment at the University of North Carolina at Greensboro.

PREAMBLE

The University of North Carolina at Greensboro (UNCG) offers this Articulation Notice to Southwestern Community College (SCC), in its continuing effort to serve educational needs of the State of North Carolina and its citizenry.

This Articulation Notice pertains to those SCC students earning one of the following Associate in Applied Science (A.A.S.) degrees who seek to complete the appropriate Bachelor of Science degree at UNCG.

UNCG 2Plus Guidelines for North Carolina Community Colleges

- 1) Associate in Applied Science degree recipients, who are accepted into the 2Plus Program, may receive UNCG credit based upon the completion of the degree. Only credit that can be applied toward a UNCG degree will be granted. Awarded credit will consist of content-based course equivalencies and allowable free electives. Credit may be awarded for college transfer courses taken in addition to A.A.S. degree requirements. No student will receive more than 64 transfer hours from a two-year institution towards a UNCG degree.
- 2) Only grades of "C" or better transfer towards degree requirements. Students who have earned a "D" grade may be admitted to the University through the 2Plus program but will not be granted any credit or hours for "D" grades.
- 3) Credit awarded to the appropriate A.A.S. recipients will consist of content-based course equivalencies and allowable free electives. A list of these course equivalencies, based on the semester system, can be found at <www.uncg.edu/reg/2Plus.html>. Students will receive the course equivalency and the appropriate number of credit hours for each course they have completed on this list. In addition, students will be granted a certain number of free elective hours based on their individual program of study at UNCG. Students who earned community college credit on the quarter system will have their transcripts evaluated accordingly.
- 4) Admission into the 2Plus Program does not constitute admission into any major at the University. If students desire to be considered for admission into a major in which their AAS degree is not applicable through 2Plus, all credentials must be submitted and reviewed to determine whether they meet traditional transfer University requirements. If the students are admissible, their transcripts will be reevaluated by the University Registrar's Office on a course-by-course basis. 2Plus program articulation courses will not apply. Enrolled 2Plus students who wish to change their major must see the 2Plus Coordinator in the Office of Undergraduate Admissions.
- 5) A minimum of 31 semester hours must be taken and completed in residency at UNCG, 12 of which must be in the major. Hours remaining to completion of the Baccalaureate Degree vary widely according to the chosen program.
- 6) 2Plus Program students must meet the same standards as all other UNCG students for official admission into their program of study. Please see the individual requirements for each program on the following page.
- 7) The 2Plus master list of articulation courses will be continually maintained in accordance with curriculum changes.
- 8) UNCG does not discriminate on the basis of race, religion, sex, natural origin, age, and handicap. Reasonable accommodations for participation by disabled persons are made in compliance with Section 504 of the Rehabilitation Act of 1973 and the Americans with Disabilities Act of 1990.

UNCG 2Plus Program

Individual School/Dept. Admission Requirements

Bryan School of Business and Economics

2Plus program students must meet the same standards as all other UNCG students for official admission into a program of study within the Bryan School. The admission requirements are listed in the UNCG Undergraduate Bulletin for the year in which a student applies to the Bryan School. The specific requirements for admission to a program of study within the Bryan School are subject to change for all UNCG students. Refer to the current Undergraduate Bulletin on-line at www.uncg.edu/reg for details.

Nursing

All applicants to the 2Plus program in Nursing must hold an unrestricted RN license. These students will receive credit based on the National League of Nursing Mobility Profile II Exams in addition to the credit awarded in the 2Plus Program.

Human Development and Family Studies

2Plus program students must meet the same standards as all other UNCG students for official admission to the Department of Human Development and Family Studies – B-K with licensure or Early Care and Education concentration. Refer to the current Undergraduate Bulletin on-line at www.uncg.edu/reg for details.

Elementary Education

2Plus program students must meet the same standards as all other UNCG students for official admission into a program of study within the Elementary Education program in the Department of Curriculum and Instruction in the School of Education. Refer to the current Undergraduate Bulletin on-line at www.uncg.edu/reg for details. The education courses begin each fall and continue for four consecutive semesters; 2Plus Program students, therefore, must satisfactorily complete general education requirements, hold a 2.75 GPA, and achieve passing scores on the Pre-Professional Skills Test prior to the fall semester they wish to begin the program in order to complete the degree in two years.

Specialized Education Services (LD&BED)

2Plus program students must meet the same standards as all other UNCG students for official admission into a program of study within the Special Education-Learning Disabilities and Behavioral and Emotional Disabilities program in the Department of Specialized Education Services. SES 250 must be completed with a grade of at least a "C" before other SES courses can be completed. The student should make plans to complete this course at UNCG prior to enrolling. Additional requirements for admission to the teacher education program, such as satisfactory scores on the Pre-Professional Skills Test, are required as well. Please refer to those requirements in the Undergraduate Bulletin on-line at www.uncg.edu/reg.

Education of Deaf Children: Auditory/Oral (B-K)

2Plus program students must meet the same standards as all other UNCG students for official admission into a program of study within the Education of Deaf Children – Auditory/Oral – Birth through Kindergarten program in the Department of Specialized Education Services. Admission is based on a 2.7 minimum GPA and satisfactory scores on the Pre-Professional Skills Test.

Interior Architecture

A personal interview and portfolio review by the IAR department are required for admission. Also a 2.5 GPA is required on any coursework transferred into the program from another school.

Social Work

2Plus program students must meet the same standards as all other UNCG students for official admission to the Department of Social Work BSW program. Admission involves a formal application and is based on a minimum UNCG GPA of 2.3, completion of SWK 215 with a grade of "C" or better, and completion of 51 semester hours (can include transfer hours).

Textile Products – Retail and Consumer Studies, Apparel Product and Design

No individual admission requirements.

Public Health Education

Must have a 2.2 GPA and at least a C in all required health courses for admission into the professional program.

Biology

No individual admission requirements.

Hospitality and Tourism Management

No individual admission requirements.
